Smarter management of the application life cycle <u>HP Quality Center 10.0</u> is a major release that allows customers to deliver highquality software applications – from simple, stand-alone projects to composite applications that comprise dozens of interdependent applications and services. New features help customers:

- Manage enterprise-wide, complex initiatives including those that span many applications and globally distributed teams. It provides robust new features that enable the sharing of requirements, test assets and defects. In addition, centralized reporting and enforcement of standardized best practices help ensure the success of complex projects.
- Provide greater discipline for managing application changes throughout the life cycle with rich baseline and version control features for requirements, tests and test assets.
- Improve quality processes for organizations of diverse sizes and needs. HP provides offerings to address those who are just getting started (HP Quality Center Starter Edition), those with established quality processes (HP Quality Center Enterprise Edition), and those who are looking to implement a Quality Center of Excellence (HP Quality Center Premier Edition).

- Prioritize the allocation of resources both people and equipment to increase efficiency.
- Manage across the entire application life cycle to keep projects on track from proposal to production complete with workflow, demand, project and resource management.

In addition, EDS Testing and Quality Assurance Services provide an end-to-end consulting service for application quality management based on HP Quality Center 10.0.
